Objectives of Anti Ragging committee

This will be the job of this committee to look after the ragging activities and to curb these if any such activities are found to be happening in accordance with the guidelines of Hon'ble Supreme Court of India.

Under laws in India, ragging is defined as:

- 1) Any disorderly conduct by either by acts or words spoken, the effect of which is teasing, treating or handling with rudeness any other students;
- 2) Any rowdy or undisciplined activity, which causes annoyance, hardshipor psychological harm:
- 3) Raise fear or apprehension thereof in the minds of junior;
- 4) Asking the students to do an act or perform something, which such student will not do in ordinary course, which has the effect of causing shame or embarrassment so as to adversely affect the physique or psyche of a junior student.

Every single incident of ragging or abetting in ragging puts an obligation on the institution to get the FIR registered. There are provisions in the IPC, which can be used by a student to register an FIR in the nearest police station.

The institute shall punish a student found guilty of ragging after following the procedure and in the manner prescribed here:

- 1. The Anti Ragging Committee of the institution shall take an appropriate decision, in regard to punishment or otherwise, depending on the facts of each incident of ragging and nature and gravity of the incident of ragging established in the recommendation of antiragging committee.
- 2. The Anti-Ragging Committee may, depending on the nature and gravity of the guilt established by the anti ragging committee, award, to those found guilty, one or more of the following punishments, namely
 - Suspension from attending class and academic privileges. i.
 - Withholding/withdrawing scholarship/fellowship and other benefits. ii.
